# **COMPLAINT FOR PATENT INFRINGEMENT**

This is an action for patent infringement in which Plaintiff ReefEdge Networks, LLC makes the following allegations against Defendant Adtran, Inc.

# **PARTIES**

- 1. Plaintiff ReefEdge Networks, LLC ("ReefEdge" or "Plaintiff") is a Delaware limited liability company having a principal place of business at of 12024 Lake Newport Road, Reston, Virginia 20194-2742.
- 2. On information and belief, Defendant Adtran, Inc. ("Adtran" or "Defendant") is a Delaware corporation with its principal office at 901 Explorer Boulevard, Huntsville, AL 35806. Adtran acquired Bluesocket, Inc. ("Bluesocket") effective August 4, 2011.

# **JURISDICTION AND VENUE**

3. This action arises under the patent laws of the United States, Title 35 of the United States Code. This Court has subject matter jurisdiction pursuant to 28 U.S.C. §§ 1331 and 1338(a).

- 4. Venue is proper in this district under 28 U.S.C. §§ 1391(c) and 1400(b). On information and belief, Adtran has transacted business in this district, and has committed, induced and/or contributed to acts of patent infringement in this district.
- 5. On information and belief, Adtran is subject to this District's specific and general personal jurisdiction, due at least to its substantial business in this forum, including: (i) at least a portion of the infringements alleged herein; and (ii) regularly doing or soliciting business, engaging in other persistent courses of conduct, and/or deriving substantial revenue from goods and services provided to individuals in this District.

# **BACKGROUND**

- 6. ReefEdge is the owner by assignment of a patent portfolio claiming technology developed by ReefEdge Networks, Inc. ("ReefEdge Networks"). ReefEdge Networks was founded in 2000 by former executive officers from Fortune 500 companies including AT&T, IBM, and Symantec. ReefEdge Networks was founded in part to develop and market innovative solutions for the seamless user mobility issue in short-range wireless networking environments.
- 7. ReefEdge Networks was recognized for its innovations in both wireless management and security. For example, in approximately 2003, ReefEdge Networks was the first to develop and market interoperable WLAN switches and access points. ReefEdge Networks was also the first to introduce WLAN switching systems with access point management software for multi-site enterprise deployments. ReefEdge Networks was also a recognized leader in WLAN security. As an example, ReefEdge Networks' products received Federal Information Processing Standards (FIPS) 140-2, Level 2 certification, from the National Institute of Standards and Technology (NIST), which is a U.S. government computer security standard that specifies requirements for cryptography modules (FIPS 140-2, Level 2 issued on or

around 2001). More particularly, ReefEdge Networks received FIPS 140-2, Level 2 certification for the ReefEdge Networks' "Edge Controller 100x" (Software v3.1.3, Hardware v3.0) on or around August 2003 (*see* the certificate: <a href="http://csrc.nist.gov/groups/STM/cmvp/documents/140-1/140crt/140crt341.pdf">http://csrc.nist.gov/groups/STM/cmvp/documents/140-1/140crt/140crt341.pdf</a>) and for the "Edge Controller 200" (Software version 3.1.3a, Hardware version 2.0) on or around January 2004

(See <a href="http://csrc.nist.gov/groups/STM/cmvp/documents/140-1/140crt/140crt/177.pdf">http://csrc.nist.gov/groups/STM/cmvp/documents/140-1/140crt/140crt/140crt/377.pdf</a>). As a result of these certifications, ReefEdge Networks' products were deployed in several military installations.

- 8. ReefEdge Networks and Cisco cooperatively engaged in business activities. For example, ReefEdge Networks and Cisco collaborated on a security bundle for multisite WLAN networks, launched as the Cisco Compatible Wireless Security solution bundle. The initiative was sparked after Cisco's wireless LAN customers raised concern with potentially serious security issues discovered in Cisco's proprietary LEAP authentication protocol and WLAN management systems. Cisco relied on ReefEdge Networks to address their potentially serious security issues.
- 9. The patent portfolio resulting from ReefEdge Networks' innovation includes 9 U.S. issued patents, 16 foreign patents and applications. The portfolio has been cited by over 255 patents.

# COUNT I

#### INFRINGEMENT OF U.S. PATENT NO. 6,633,761

10. ReefEdge references and incorporates by reference paragraph 1 through 9 of this Complaint.

- 11. ReefEdge is the owner by assignment of United States Patent No. 6,633,761 (the "'761 patent"), entitled "Enabling Seamless User Mobility In A Short-Range Wireless Networking Environment." The '761 patent issued on October 14, 2003. A true and correct copy of the '761 patent is included as Exhibit A.
- 12. Bluesocket has known about the '761 patent since at least May 2004, when it filed an information disclosure statement the PTO during the prosecution of Bluesocket's United States Patent No. 7,042,988 that cited the '761 patent. The '761 patent was also cited and relied upon by Bluesocket in an information disclosure statement filed to the USPTO on May 2004 during the prosecution of United States Patent No. 7,126,937, cited and relied upon by Bluesocket in an information disclosure statement filed to the USPTO on May 2004 during the prosecution of United States Patent No. 7,146,636, and cited and relied upon by Bluesocket in an information disclosure statement filed to the USPTO on May 2004 during the prosecution of United States Patent No. 7,260,638. As a result of Adtran's acquisition of Bluesocket, Adtran has also been aware of the '761 patent since at least August 2011.
- 13. Addran has been and still is directly infringing at least claims 13 and 33 of the '761 patent, literally and under the doctrine of equivalents, by making, using, selling, offering to sell, or importing, without license or authority, products and services that enable seamless user mobility in a wireless networking environment by, for example, dynamically registering access points with a server, registering a user device with an access point, and handing off a user device to another access point wherein the hand off does not disrupt wireless networking services to the user's devices. For example, Adtran's Wireless Controllers (including the BlueSecure 5200 wireless), Access Points (including the Bluesocket 1800 access point) and related software (such as Bluesocket's management software) infringe at least claims 13 and 33 of the '761 patent. By

- 34. Unless a permanent injunction is issued enjoining Adtran and its agents, servants, employees, representatives, affiliates, and all others acting or in active concert therewith from infringing the '308 patent, ReefEdge will be greatly and irreparably harmed.

#### PRAYER FOR RELIEF

WHEREFORE ReefEdge respectfully requests that this Court enter:

A. A judgment in favor of ReefEdge that Adtran has infringed, directly and jointly, jointly, and/or indirectly, by way of inducing and/or contributing to the infringement of the '761 patent, '864 patent and '308 patent;

- B. A permanent injunction enjoining Adtran and its officers, directors, agents, servants affiliates, employees, divisions, branches, subsidiaries, parents, and all other acting in active concert or participation with them, from infringement, inducing the infringement, or contributing to the infringement of the '761 patent, '864 patent and '308 patent;
- C. A judgment and order requiring Adtran to pay ReefEdge its damages, costs, expenses, and prejudgment and post-judgment interest for Adtran's infringement of the '761 patent, '864 patent and '308 patent as provided under 35 U.S.C. § 284;
- D. An award to ReefEdge for enhanced damages against Adtran resulting from the knowing, deliberate, and willful nature of Adtran's prohibited conduct regarding at least the '761 patent, as provided under 35 U.S.C. § 284;
- A judgment and order finding that this is an exceptional case within the meaning of 35 U.S.C. § 285 and awarding to ReefEdge its reasonable attorneys' fees against Adtran;
- F. Any and all other relief to which ReefEdge may show itself to be entitled.

# **DEMAND FOR JURY TRIAL**

ReefEdge, under Rule 38 of the Federal Rules of Civil Procedure, requests a trial by jury of any issues so triable by right.
